Any US resident taxpayer can file Form 1040 for tax year 2017. You do not have to file the short Form 1040A or easy Form 1040EZ. Nonresident taxpayers will file the 2017 Form 1040-NR. Commonwealth residents will file either Form 1040-SS or Form 1040-PR.
