Mental health records, applicable objective tests such as IQ and memory impairment testing, and reports from your psychiatrist or other mental health care provider are the primary types of evidence you will have to prove your disability claim. However, these are not the only types of items to submit. The SSA will review any viable evidence you provide them with, even from non-medical sources, such as:

A 10 percent disability rating for mental health conditions is contains even less severe symptomatology: "Occupational and social impairment due to mild or transient symptoms which decrease work efficiency and ability to perform occupational tasks only during periods of significant stress, or symptoms controlled by continuous medication."
