The lawsuit seeks to stop the Department's garnishment of wages from defaulted student loan borrowers and to force Education Dept. to immediately comply with Sec. 3513 (e) of the CARES Act that mandates that all such collections be ceased until at least next September. An estimated 285,000 borrowers may be eligible class members.
