Even today, the UK government does not publish an official reporter. However, both its Courts and the Bluebook suggest citing to the English Reports for pre-1865 cases whenever possible. After 1865, cite to the official Law Reports (link is external). Other reporters, such as the Weekly Law Reports and the All England Law Reports, may be used if a case has not been reported in the Law Reports.
